

Minutes of a meeting of Bilsington Parish Council held at Bilsington Village Hall on Thursday 26th March 2026 at 7:00pm.

1245. Apologies for absence:

1246. Declarations of Interest:

There were no declarations of interest.

1247. Neighbourhood Watch:

Report attached.

1248. Kent County Councillor's Report:

Cllr Barrett reported on the appalling condition of the roads and that it had been estimated that it would cost in the region of £111 million to deal with all of the potholes. To warrant an emergency repair of a pothole it needs to be in excess of 50mm deep these can be reported using the online tool or by phone on 0300 041 9191. New contractors are being used by Highways with effect from 1st May.

1249. Ashford Borough Councillor's Report:

Cllr Harman reported on the proposals for the redevelopment of Elwick Place and the former Odeon Cinema in the High Street referencing comments that had been made on Social Media, the final designs for these are awaited.

Cllr Harman recently met with Kent Highways manager regarding the state of the B2067 in particular potholes, the manager drove the full length through from Aldington to Hamstreet finding one that needed attention. All potholes are assessed on a risk base approach to determine if repair is needed.

REPORT TO BILSINGTON PARISH COUNCIL MARCH 2026.

All the matters of routine crime prevention remain the same, however the war in the Middle East could lead to

FUEL THEFTS

- 1 Fuel syphoned at night from parked cars and vans.
- 2 Theft of fuel from parked HGVs
- 3 Theft of fuel from storage tanks ie. Farms and plus Farm machinery.
- 4 Thefts of number plates to assist drive of thefts from garage forecourts.
5. Theft of domestic heating oil from residential storage tanks.

A concern with my ex fire service head on is if a fuel shortage or panic buying occurs people will purchase fuel in correct containers but decant into wholly inappropriate plastic containers and store them in vehicles, sheds and garages. A simple shed fire suddenly becomes a napalm inferno.

I hope matters ease however costs may drive a crime trend and we need to be alert, vigilant and ready.

ANIMAL CRIME

As Spring arrives, I will be running campaigns to warn and highlight rural crimes for example dog attacks on sheep, sheep worrying, and care around horses.

Sadly, it is not always visitors into the countryside but locals who forget the basic rules.

Speed around roads where horses could be is a definite concern.

Protecting livestock – signage available

Owners are urged to keep dogs away from livestock, on a lead near farm animals and be aware of where their dogs are at all times while on countryside walks.

Property owners near fields where livestock are kept are also asked to ensure their gardens are secure, so pets can't escape.

Rural roads are not racetracks

Whatever road you drive on, remember who you share the road with. Always drive at a safe speed for the road conditions and never exceed speed limits.

CROSSING HORSES WIDE AND SLOW CAN PREVENT THE DEATH OF DRIVERS, RIDERS AND HORSES.



What is Pass Wide and Slow?

Pass Wide And Slow is a Facebook group set up to encourage and educate drivers how to pass horses safely on the road.

PASS WIDE & SLOW AWARENESS RIDE/DRIVES



In the wild a horse is a 'prey' animal, that is they are DINNER and have therefore developed a fright/flight response to anything that scares or startles them (known as spooking).

A horse's natural response to something that spooks them is to run, kick out or spin and look.

No matter how well they are trained, occasionally nature takes over. If it makes you jump, it will make a horse jump - that bird suddenly erupting from a tree could be a tiger!

A horse can spook sideways at up to 50mph.

A horse can beat many road legal vehicles at 0-30mph.

A horse's back legs can kick out a surprisingly long way.

SO...

Give 2 metres width where possible.

When passing (from front or behind) slow to 10mph. If you are approaching a horse head on at 30mph and that horse spooks, that is an impact speed of 80mph!

Cyclists - please call out if approaching from behind, a voice is less scary (especially if riding into the wind, when even the horse may not hear you).

A carriage should be classed as a LONG vehicle.

Please look at the rider. If they are asking you to stop or slow, they are doing it for a reason (they are NOT waving!).



MYTH BUSTERS

Drivers may say:

Horses shouldn't be on the road - why not?

Should ride in the fields -
Fields are privately owned, and to get to any that allow us to ride in, or bridleways, WE HAVE TO USE THE ROADS.

You don't pay road tax - neither do you!
Road tax was abolished in 1937.
Vehicle emission tax also doesn't apply to bicycles, classic cars, vintage cars, and electric cars.

Are you insured? - There are probably more horses insured on the road than cars!

Only toffee-nosed, rich, entitled people own and/or ride horses riders come from all walks of life - nurses, lorry drivers, police officers, shop workers - to name but a few.

which have been often expressed to horse riders!

PLEASE REMEMBER,

The riders are all someone's mum, dad, son, daughter, brother or sister.
The horse is a member of their family.
Don't leave a ghost behind.



10mph

Slow down to a maximum of 10mph.



Be patient

I won't sound my horn or rev my engine.



Pass wide

Pass the horse wide and slow (if safe to do so), at least a 2 metres if possible





Staying safe as a horse rider

- **Be visible** – wear high vis clothing. A tabard or vest and leg bands for your horse.
- **Use appropriate hand signals** – make sure drivers know where you are planning to go.
- **Observe your horse** – if your horse shows signs of stress, try to pull over to give your horse time to settle.
- **Thank drivers** – a nod or wave to a driver encourages people to continue to take care around horses.
- **Think ahead** – plan your route and let somebody know where you are going.
- **Consider the conditions** – avoid roads in poor visibility, weather or heavy traffic/roadworks.
