

Minutes of a meeting of Bilsington Parish Council held at Bilsington Village Hall on Thursday 12th February 2026 at 7:00pm.

Present: Councillors; S Hudson (Chair), M Bilham, A Evans and R Thompson.

1232. **Apologies for absence:**

1233. **Declarations of interest:**

There were no declarations of interest.

1234. **Neighbourhood Watch:**

Report attached.

1235. **Kent County Councillor's Report:**

No report submitted.

1236. **Ashford Borough Councillor's Report:**

Sorry I cannot be with you this evening. Tonight, I am in the ABC Cabinet 2026-27 budget setting meeting ahead of Full Council on 26th February. Prior to talking about this, I have noticed that, for some reason, Bilsington PC meetings now clash, on almost every occasion, with either ABC activity or Ruckinge Parish Council. This makes it difficult for me, but I will do my best to maintain some presence, even if only briefly or by alternating which parish I attend. Please rest assured that I remain available to you and to Bilsington residents via the usual channels; by phone, email or social channels.

The annual budget is obviously the focus at this time of year. This year Government announced a 3 year settlement for local councils. Ashford, as for many rural boroughs, came off slightly worse than previous years as priority was given to urban and coastal areas of deprivation. However, as is usually the way with these things, Government takes with one hand and gives with the other and so over all ABC is happy and confident with its financial position at present. Careful financial management and no vanity projects by this administration have ensured that we are in a sound financial position. Our budget sets out how we will continue to deliver against our key Local Priorities and Projects. These include:

- Major focus on redeveloping key town centre sites: Kent Wool Growers, Park Mall, the former Odeon, and former Civic Centre.
- Ongoing programme to deliver around 1,000 new council homes over the next decade.
- Continued initiatives to reduce homelessness, which remains one of the biggest risks to the council. This includes purchasing properties and repurposing stock for temporary accommodation.

The borough council tax rise will be 2.99%, or £5.79 per year for every Band D property, if approved at Cabinet and Full Council. It is important that councils levy the

increases allowed. Costs, as we are all personally aware, are constantly rising and Government calculates the permitted annual increase into the funding they allocate local councils – so if a council chooses not to levy as it can, then the shortfall inevitable means service or staffing cuts, or additional borrowing.

You may have seen that Government have published consultation on the 4 options put forward by the Kent councils for Local Government Reorganisation in Kent. Maybe the Clerk could circulate the link? I have shared it on my Facebook Page. Ashford's preference is for 4d – which proposes reorganisation around transport routes and proposes a slightly higher number of councillors. The biggest threat from LGR to local democracy is the reduction in local representation. But then, I would say that, wouldn't I? Please do look at the proposals and put in your view.

Lastly, in case you haven't seen it elsewhere, I'd like to bring your attention to our Beat Officer, PC Stuart Picton, will be holding a Coffee with a Cop session at Hamilton Tea Rooms between 2-3pm on Wednesday 18th March.

Chair's comments: The meeting dates were agreed by the Council on Thursdays as suitable for its members any potential clash of dates was incidental as neither the Borough Council or Ruckinge dates for the full year had been published. The link for the consultation of Local Government Reorganisation has been circulated to all members.

1237. Public participation:

The agent for the Planning consultation on Lanary Oast spoke to clarify the reasons behind the application and the owner's circumstances.

1238. Minutes:

The minutes of the Parish Council meeting held on 18th December 2025 were submitted, agreed as a true record and signed by the Chair.

1239. Highways:

The Village Gateway on Bonnington Road and Ashford Road have been scheduled for installation and notices of road closure have been posted to allow the works to be safely undertaken. Unfortunately the funding from the Kent County Councillor has proved to be unavailable as it has to be an internal application as opposed to one submitted by the Parish and the cost has already been settled. This will be taken forward with the member to see if he can assist with the second phase of the project.

Whilst the Highways Improvement Team have stated that nothing can be done with Rucking Road, the Officer is changing roles and a replacement will be instated in due course, when this has occurred a fresh approach to the issue will be raised.

1240. Planning Matters:

Planning application PA/2025/2253 Lanary Oast, Ashford Road – Removal of conditions 1 and 2 of planning permission 17/01806/AS – Amended description – Description has been amended to provide a more accurate representation of the proposal.

Resolved: The Parish Council will support the decision of the Borough Council if it is mindful to grant the application.

Planning application PA/2025/2392 Weavers Cottage, Ashford Road – Listed building consent for a two-storey rear extension and associated works to include dormer windows following the demolition of both the side and rear later additions.

Resolved: The Parish Council supports the application.

Planning application PA/2025/2366 Weavers Cottage, Ashford Road – Proposed two-storey rear extension and associated works to include dormer windows following the demolition of both the side and rear later additions.

Resolved: The Parish Council supports the application.

Planning application PA/2025/1347 The Priory Home Farm Livery, Priory Road – Change of use for the existing livery business to sui generis for therapeutic classes with the existing livery animals and those specifically kept for equine therapy, along with general riding & carriage classes (Retrospective).

Resolved: The Parish Council object to the application as not all licenses/permissions for the activities are in place including but not limited to the kennels and the mobile home. The Parish Council is also concerned about the cumulative effect of traffic with the other businesses both on site and adjacent namely the tea rooms, weddings, campsite and burial ground.

Planning application PA/2025/1843 Ragstones, Newchurch Road – Proposed single-storey side extension to form a garage.

Resolved: The Parish Council supports the application.

Planning application PA/2026/0064 Mulberry House, Brisley Lane – Proposed detached triple garage with loft room.

Resolved: The Parish Council has no objection to the proposal subject to the garage remaining ancillary to the domestic dwelling.

1241. Finance:

1242. Village Hall:

The annual fruit and flower show is being absorbed into the Village Hall operations, this year's show will be on 1st August.

I do not for one moment anticipate that 2026 will in anyway slow down on crime challenges from what we faced in 2025, in fact I expect an increase. Scams will come harder and faster, and I expect an absolute flood which we will need to be at our best to resist and help our vulnerable and elderly who will especially be targeted.

Most of my report is my personal action plan to tackle crime in 2026.

This is my planned statement about how I will work. This report is my scene setter for 2026.

I will look to see and support the Beat Officer principle of the Kent policing model launched in June of 2023, which is only just reaching full establishment.

I will look to support and help deliver the principles, goals and targets of the Police and Crime Commissioner's Police Plan.

THE KEY WORD IS.....PREVENTION especially avoidable and preventable crimes.

“The defining features of Neighbourhood Policing can be traced back to Peelian principles. The clear emphasis being on prevention.” (Sir Robert Peel 1829 established the Met Police)

This fits exactly into the role of Neighbourhood Watch (NHW). This is my bread-and-butter work.

NHW working together, looking at crime trends and crimes in the wider district we can keep communities as crime free as possible and the residents free from being a victim of crime.

Equally as important to keep residents, especially the vulnerable and elderly, free from the fear of being a victim of crime also. Criminals will target those groups!

Never ever has there been a mandate to be organised and responsive to crime activity, but every step of the way we have the most proactive crime prevention plans and strategies we can.

It will allow us to set out to other partners and the police “this is all we are doing in the locality and the community.” Our partnership will now be developed still further with your support, and we head into the 2026 in good shape with clear objectives of the challenges we face.

In 2026 my plan will work as follows.

I will meet with the Police Crime Commissioner.

I will meet with the Members of Parliament for the area.

I will work with KCC Councillors for each area.

I will bring/or send a report to each council meeting that I attend.

I will attend as many council meetings as I possibly can.

I will attend, if possible, The Annual meeting of each Council and make a presentation.

I will continue to build NHW membership and surrounding areas NHW Membership

I will continue to engage with residents through many forums

I will continue to use the Facebook facility across all groups I contribute to.

I will look to explore other communication platforms during 2026, which were piloted in 2025.

I will look to use the council websites for the issuing of crime prevention advice.

I will contribute to Council and Councillors Newsletters with any space granted.

I will develop still further the number of magazines I now contribute to, as these reach many elderly and vulnerable people who do not have access to modern media platforms as they are hand delivered to each door.

NEIGHBOURHOOD WATCH PLAN for 2026

This will be the plan that I work to during 2026. I will present this to my Neighbourhood Watch Members and to partners especially the following.

1. Individual councillors
2. Community and Parish Councils across the District
3. Ashford Borough councillors
4. Kent County Council councillors
5. Any agency that helps to provide support to the Community.
6. Support the Police Crime Commissioner in his campaign's goals and targets.
7. To press for an intelligence lead crime prevention approach in areas.
8. To meet with MPs, KCC Councillors and local councillors
9. Support other NHW areas across Kent with help, advice and campaigns.
10. To continue to review throughout the year and try to improve and be better.

I will look to work as closely as possible with Kent Police especially the Beat Officers to help keep the communities safe and secure. Shortfall of police performance will be raised in a constructive way, supporting their stated principle of **“Challenge ourselves to improve”**

My work will be to keep residents as crime free as possible and, also as important, free from the fear of being a victim of crime.

That will be achieved by:

1. Providing as much crime prevention and safety advice as possible to prevent crime occurring in the first instance. **PREVENTION IS THE GOAL**
2. When a crime has occurred, to prevent a similar crime nearby and then prevent a crime trend developing across the wider district, whilst at the same time support front line officers to obtain evidence, witnesses, and information to assist in investigations whilst supporting the victims of crime.
3. The re issue of crime prevention and advice from the information learnt from crime investigations.
4. Being a critical friend to the police and help identify and rectify perceived shortfall of performance by the community.

IN SIMPLE TERMS

Can we prevent crimes in the first place? if they occur can we provide as much support to the Police as we can and support the victims. Can we learn from those crimes and issue better more informed and targeted crime prevention from those “lessons learned”.

HOW WILL I ACHIEVE THAT?

1. Recruiting, growing and developing still further NHW across the District
2. Support and help develop other NHW districts across Kent.
3. Develop still further Facebook groups across communities.
4. Develop still further other media platforms to communicate quickly with communities e.g. Nextdoor, WhatsApp, X (Twitter) building on 2025 work.
5. By writing and contributing to Community magazines.
6. By writing and contributing to Council Newsletters and Magazines.
7. By writing and contributing to Individual Councillors newsletters.
8. By developing still further NHW on Council Web sites.
9. By contributing when requested by local and national media platforms.
10. To make presentations at the Annual Electors meeting of Parish and Community Councils
11. By holding public Engagement meetings and surgeries through the year.

Items 2,5,6,7,9,10 and 11 above are essential to address my concerns that Kent Police rely heavily on internet platforms to communicate, many residents especially the elderly and vulnerable in communities only have a landline telephone. My plan will not and must not leave them behind.

I make no comment on the effectiveness or how Kent Police communications platform MY COMMUNITY VOICE has worked to date or is working. That assessment will be made by the end users, the people in communities! I have a proven track record with NHW over 7 years, it will be for MCV to try to match those. The public will judge. Our residents are not actually too concerned how they are told, they just want to be told! The public will select on performance and consistency.

Residents and councils will decide on performance and effectiveness, and I am very confident that my work with Neighbourhood Watch in communities has stood the test of time and my performance will continue to grow and develop very strongly.

My continued goal is to lobby and seek a root and branch review of communications in Kent Police with very simple terms of reference.

'How does Kent Police want to communicate with residents in the years 2026 to 2030'. Can those communications be braver, quicker and more effective.

'How are current communications working and their effectiveness?

'What are the approved methods for use in the communications process and are they still right and effective in 2026 to 2030.

This year my own personal 10-point approach which will be:

1. To carry out proactive **CRIME PREVENTION** with special attention to the elderly, and vulnerable residents who will always be targeted by criminals. Special groups will require special attention. This will involve having a constant developing and adjusting "**DYNAMIC ONGOING RISK ASSESSMENT**" "of what we will face. Also called **CLOUDS ON THE HORIZON**

2. To target **PREVENTABLE** and **AVOIDABLE** crimes to reduce demand on the police. To support delivery of the Police and Crime Commissioners Plan for policing of Kent.
3. **IF CRIMES OCCUR:**
 Try to prevent further crimes in the direct area.
 To support victims of crimes.
 To support and assist operational police colleagues and make appeals/collect evidence, especially any form of CCTV.
 To go again into the community with crime prevention from lessons learnt.
 To look and act quickly where crime trends occur in the wider Kent areas.
4. To target **ANTI SOCIAL BEHAVIOUR/ CRIMINAL DAMAGE/ FLY TIPPING & RURALCRIMES, ESPECIALLY ANIMAL CRIME.**
5. To target **DRUG ACTIVITIES** that drive so much other crime.
6. To target **KNIFE CRIME**
7. To target **VIOLENT CRIME** and especially support the **VIOLENCE AGAINST WOMEN AND GIRLS CAMPAIGN** and push for prevention to be to the forefront.
8. To try to stay ahead of the **SCAMS/BOGUS CALLERS/ROGUE TRADER EVENTS** develop still further **MY FACEBOOK SCAM LIBRARY**
9. To continue to build a strong **NHW MEMBERSHIP** across the District and to **ENSURE ALL CRIMES** are reported and crime numbers obtained so that the progress can be followed up on and the police can be held to account on lack of perceived response/shortfall in performance and then raise concerns in the correct manner to try to improve.
10. **PUBLIC ENGAGEMENT** To hold regular Public Engagement meetings using many of the Community Hubs that now operate. These events will allow face to face dialogue with residents and will require the operation of that underused skill we all have which is **"LISTEN TO RESIDENTS CONCERNS AND WORRIES"**

That also will be a major factor in shaping ongoing crime prevention from myself and to provide vital intelligence, especially to Beat officers to help shape and plan proactive patrols and interventions on hot spot issues.

SPECIAL PERSONAL CAMPAIGNS THAT WILL SUPPORT MY GOALS

1. OPERATION ROLLING THUNDER

The ongoing building and growing of Neighbourhood Watch across the Ashford District. To support East Kent Colleagues in Canterbury Folkestone and New Romney District NHW Groups. To support the many other NHW groups across the whole of Kent.

2. OPERATION HORIZON

To continue to work and develop relationships on new build sites with planners, developers, sales teams, councils and councillors to enrol residents into NHW from the moment they move into their new homes.

NHW is about preventing crimes, but I am also a community builder too!

Crime cannot flourish in communities that are alert, vigilant and care!

3. OPERATION EVEREST

To continue to develop and build my membership of Nepalese residents into NHW to help prevent the targeting of this group in our communities.

A Nepalese resident will be in the NHW scheme for the road or area they live but will also be in a special alerting communication group for Nepalese persons anywhere in Kent.

If information is received from the police or the community of a Nepalese family being targeted, I can alert Nepalese families across Kent.

4. OPERATION GUARDIAN ANGEL

Developed to help protect the vulnerable and disabled in our communities who will be targets for Scammers, Rogue Traders, and Bogus Callers not just by phone or computers etc but also by face to face on their doorsteps. Add a relative's details to the

vulnerable persons details so a family member is helping with the warnings This is vital with helping my members with dementia.

5. OTHER CAMPAIGNS

To continue to support all other campaigns and react to a sudden crime trend for example,

DRUGS (remember this crime drives so much other crime in communities.

VIOLENCE AGAINST WOMEN & GIRLS

ALL VIOLENT CRIME

KNIFE CRIME and KNIFE CRIME CAMPAIGNS

RURAL CRIME

HERITAGE CRIME

ANIMAL CRIME

FLY TIPPING

ANTI SOCIAL BEHAVIOUR

CRIMINAL DAMAGE

TO DELIVER THE CRIME COMMISSIONERS SPECIAL CAMPAIGNS THROUGH THE YEAR INCORPERATING POLICING PRIORITIES.

BE READY TO RESPOND TO ANY OTHER DEVELOPING CRIME TREND OR RISK.

6. COMMUNICATIONS

To continue to explore and develop and improve communications into the community.

Emails, Facebook, WhatsApp, Nextdoor, Magazines, Council Websites, Council Newsletters, Councillors Newsletters, Community newsletters.

The newsletters and magazines ensure I leave no elderly/vulnerable person behind as they may not have modern media platforms just a landline telephone. To use local media and national media when the opportunity arises.

IMPORTANTLY WITH ALL NEIGHBOURHOOD WATCH WORK.

To be on the front foot and proactive to provide an intelligence led model to support the police and be dynamic and relentless on crime prevention and safety advice to keep communities free from crime and residents free from the fear of being a victim of crime. Above all react to sudden changes in crime trends. I have the honour to serve the communities, and this document provides a plan to achieve that most important goal.
